

BUILDING CAPACITY TO BETTER SERVE THE COMMUNITY

It is our great pleasure to announce that construction has just been completed on the "Dr. Lucille Garber Ford Wing" at the Ashland County Community Foundation.



Four cherished donor families provided 100% of the cost of construction and furnishings, led by its inimitable namesake, Dr. Lucille Ford, Founding President of the Community Foundation.

This 768-square-foot building addition is the manifestation of ACCF's vision of building capacity within its own organization, in order to facilitate the expansion of capacity in those whom we serve on both sides of the philanthropic exchange.

The new wing consists of three new offices, providing much -needed space for staff members Kristin Aspin, Chief Program Officer; Brittaney Reep, Chief Financial Officer; and Lanie Hartge, Educational Programs Director. Each of them had previously been working in cubicle spaces, or on the lower level of the building.

Also, this provided the opportunity, and necessity, of creating first-floor, handicap-accessible restrooms. previous configuration had restrooms that only existed on the lower level of the building, with no elevator access for elderly or affirmed visitors.

Funding for the three professional offices were provided by long-time ACCF supporters Charles and Jane Taylor, Dr. Stan and Diana Brechbuhler and Mike and Tammy Buckingham, in honor of his parents, Bill and Martha Buckingham.

"We're extremely grateful to the donors that have made this possible, and proud of the progress that we've made over the past 22-plus years, culminating in this significant event in our history," stated ACCF Executive Director/CEO Jim Cutright.

Simonson Construction Services, Inc. was the general contractor providing the design/build expertise, as well as some generous in-kind services, to keep the new addition on-time and under budget.

Cutright went on, "It is only fitting that this wing carry Dr. Ford's name. Her leadership in the formational years of ACCF has led us to this point in time, where we can set the stage for an even greater future. As she passed the torch to me in 2012, my goal has been to preserve our history, while building what I call a 'Template of Success' for the future. included strengthening our stewardship capabilities, through the building of staff capacity, which has in turn required us to think about, not just monetary assets, but physical assets, as well.

In order to demonstrate stability to our donors and encourage long-term sustainability for the agencies we serve, it's important that we be viewed as an anchor institution in our community. Nothing says that better than a permanent home. Our 300 College Avenue address, and its beautiful new Dr. Lucille Garber Ford Wing, is the perfect representation of that permanence."

A formal dedication/open house is planned for early Spring.

FROM THE EXECUTIVE DIRECTOR (CUTTY'S CORNER)



So many positives...so little newsletter space..!

With December 31 marking the halfway point through our fiscal year, we pause to thank our valued Donors and Partner Agencies that have embraced ACCF's unique model of philanthropy, that of

establishing long-term support of our community through endowment-building.

Already, through 6 months, **28** new funds have been created with 28 unique stories of why:

Scholarships

Two were created in loving memory of a deceased spouse; two others specifically for nursing or education majors; one by a high school class, celebrating its 50th class reunion.

Donor-Designated Funds

Nine total, including those that will provide annual support for a donor's church or university; non-traditional educational opportunities; the arts; and a local high school athletic program.

Community Grants Funds

Three new funds were created, the assets of which will be pooled with many other funds to provide a discretionary grants pool for distribution each year through ACCF's Community Grants program.

Agency Funds

Four new permanent endowment funds were established to provide long-term support to non-profit agencies providing much-needed community services.

Donor-Advised Funds

Seven new funds will allow donors the opportunity of making their own personal grants to organizations about which they care, with the ability to vary which agencies will be the recipients, year-to-year.

I must say that donor-advised funds have definitely struck a chord with new donors, as they enjoy the tremendous flexibility that these instruments can afford. Also, with the new tax laws potentially limiting tax deductibility of some charitable giving, based on your individual circumstances, donor-advised funds can be an excellent tool for maximizing gifting capacity.

As we look ahead, we continue to look for opportunities to make an impact in our community with the gifts you have made possible.

This past year, we offered seed money to the "North Central Workforce Alliance" for a program where teachers were bussed to area manufacturing and construction firms, so that they could become aware of career opportunities for their students that may exist outside the college pathway.

We provided a "kick-start" grant to a group branded as "Ashland Young Professionals," a new generation of youthful leaders, ages 21-40, who want to make a difference in our community.

Additionally, we funded, in collaboration with others, the production of a video addressing the mental health and opiate addiction challenges associated with adverse childhood experiences.

NEW \$500,000 FUND ESTABLISHED

Mr. Bob Simonson, Founder of Simonson Construction Services, Inc., met with ACCF Executive Director Jim Cutright in late December to create a new \$500,000 donor-advised fund, to be known as the "Robert Simonson Family Charitable Fund."

"Obviously, we're ecstatic to receive such a remarkable gift. Bob has been a long-time supporter of ACCF at a high level, so he appreciates the concept of endowment as a means of giving back to the Ashland community," said Cutright.

This past fall, approximately 80 women gathered to recognize the impact of the ACCF's Women's Fund. The Women's Fund Annual Gathering served to bring Women's Fund donors and friends together to learn about the Women's Fund, hear highlights of the year, recognize current year grant recipients and present the Dr. Lucille G. Ford "Freedom from Selfishness" Award. To date, **61 grants totaling \$98,418** have impacted **6,965 women and children** in Ashland County, thanks to the generosity of **489 donors** to the Women's Fund.

DR. LUCILLE G. FORD "FREEDOM FROM SELFISHNESS" AWARD



Ann Miller was named the 2017 recipient of the "Freedom from Selfishness" Award, created and named in honor of Dr. Lucille G. Ford, the Community Foundation's founding president.

"What an honor," she said. "This is marvelous. I don't think of myself as anything special. You just do what you need to do and you look around and see what else might need to be done. You make a list. You go down the list as far as you can each day and start over the next day. I'm flabbergasted by this because I don't think I do anything that I don't think anybody else will do but thank you very much for the honor. I appreciate it."

Miller has been involved with Trinity Lutheran Church, Junior Achievement, 4-H and Ashland Evening Lions Club.

Ford said Miller was being very modest. "She only gives you a fraction (of her philanthropy)," Ford said as she turned pages one, two and three of Miller's nomination form. "And this is all small type. This woman is absolutely phenomenal."

The Dr. Lucille G. Ford "Freedom from Selfishness" Award was created in 2013 by the ACCF's Women's Fund. Recognizing and honoring Dr. Ford, who defines philanthropy as "freedom from selfishness," this award recognizes Ashland County women who demonstrate a long-standing commitment to philanthropy.


