Momentum builds for Childcare Initiative

It started two years ago with a question—What is the one thing holding Ashland County women back?

The answer our Women's Fund Steering Committee kept returning to was childcare.

For a single mother with two children, childcare costs account for nearly 75 percent of median income, on average.

Many parents in our community find themselves in a bind. They can't afford to work, but they can't afford not to.

Even when they can come up with the money, families face waitlists for childcare spaces, and they often find care is not available outside traditional work hours.

We're pleased to report that the Women's Fund Childcare Initiative is making strides to expand access to high-quality, affordable childcare in Ashland County.

By starting a new childcare center in our city's industrial park, this initiative is creating additional childcare spaces for families in our community who need them most. A newly-formed nonprofit organization, Foundations Community Childcare, will own and operate the center while striving to meet families' needs for affordability and access.

Located on donated land on Ford Drive in Ashland Business Park, Foundations Community Childcare will be in close proximity to 27 businesses with a combined 1,200 employees.



The center is slated to open by the end of 2023 with a 12,400-square-foot facility and an initial capacity to serve up to 150 children, infants through school age. The 3-acre site allows room for potential future expansion.

The center's innovative funding model includes both income-based and employer-supported tuition assistance as well as grant funding and endowment. This will allow the center to operate sustainably while remaining affordable for families.

Families' needs will determine the center's services, including non-traditional work hours. Ashland County has no licensed childcare available past 6 p.m., and many employees in the industrial park work 12-hour shifts or have second or third-shift jobs.

While Foundations Community Childcare will own and operate the center, our Women's Fund Steering Committee has undertaken a fundraising campaign in support of the new nonprofit.

In the past 12 months, 51 new endowment funds were created—the most ever in a single year. We're very pleased to report that we have now "given back" over \$22 million to our community, in the form of grants, scholarships and distributions to our nonprofit partners!

Not to mention the great success, thus far, of our Women's Fund Childcare Initiative, which is sure to be the hallmark effort of this next year, so we look forward to sharing that success story with you in 2023.

The Women's Fund Childcare Initiative's \$4.5 million goal includes construction and start-up costs as well as an endowment component for sustainability.

In June, the committee announced a "Month of Giving," inviting the entire Ashland County community to join the campaign.

In a single month, donors gave an amazing \$255,423. The first \$200,000 was matched by SJE, Inc., bringing the total impact of the "Month of Giving" to \$455,423.

To date, the committee has raised \$3.4 million, including grants and support from nearly 200 individual donors and businesses. Committee members hope to wrap up the campaign by the end of the year.

This collaborative project is so unique, it has drawn statewide attention from media outlets, other community foundations and communities who have similar needs.

- A son created a donor advised fund in celebration of his parents' retirement from their family business. "It's the most awesome gift we could imagine," one of the honorees said. "It's so cool — that we get to live on like this, and other people will benefit? I'm honored."
- A member of the Ashland High School Class of 1972 created a new Community Grants fund and challenged his classmates to donate to the cause as well. Together, the class will contribute at least \$50,000 to bolster ACCF's grantmaking capacity, ensuring the class leaves a legacy of caring for their community.

"While we cherish opportunities to help families remember deceased loved ones with memorial funds, we find that establishing honorary funds can be especially rewarding," ACCF President/CEO Jim Cutright said.

"The honored individuals have a chance to see the impact of the gift during their lifetime, as well as to know their legacy will be carried on in perpetuity."

We have several fund types with varying levels of involvement for donors or honorees. Some fund types allow donors to "set it and forget it," while others give donors the flexibility to steer distributions from their fund.
