Celebrating 30 Years of Giving

The number 30 carries special meaning for the Ashland County Community Foundation this year.

Along with celebrating our 30th birthday, we are excited to reach the milestone of giving back more than \$30 million to the community in the form of grants, scholarships and distributions.

Encouraging individuals, families, organizations and businesses to take the next step in their charitable giving seemed like a great way to honor these achievements and continue to honor our mission.

We are celebrating by offering 30 one-time "30th Anniversary Grants". Grants are awarded in the form of \$5,000 matches to create a new endowment fund or donor advised fund at ACCF.

These matches are available until June 30, 2025, or when we have reached a total of 30 new funds. Donors may choose from a range of fund types to match their charitable interests and their desired level of involvement in grant distributions made from their fund. Fund



minimums range from \$10,000 for donor advised funds, agency funds and community grants funds to \$15,000 for donor designated funds, field of interest funds, scholarship funds and unrestricted funds.



We're wrapping-up yet another successful June 30 year-end here at ACCF!

Our amazing growth story continues, as we finished 2023-2024 with just over \$90 million in assets, spread

across 683 endowment funds under stewardship. This has made it possible for us to reinvest over \$30 million in scholarships, grants and distributions to worthy students and our nonprofit partners over these past 29 years!

I'm trying not to overdo the exclamation points here, but this is exciting stuff, Gang!!

As we look ahead, and as you'll read elsewhere in this publication, we're positioning ourselves to effectively manage this growth by building out a capable team of professionals, matching skill sets to needs, with a view to where we're headed, not where we've been.

Speaking of "building," our unique model of creating very targeted part-time positions produces a desirable work/ life balance for our staff, but that also means a higher headcount. So, to accommodate that, we're very pleased

to announce that we will be constructing a new addition on the west side of our building in the coming year!

Thanks to a handful of very generous donor families, we have raised the necessary funds and are hoping to begin construction in Spring 2025.

Aesthetically, the design will mirror the "Dr. Lucille Garber Ford Wing" added to the east side of our building back in 2018. The plan adds sorely needed storage space, as well as six new offices to accommodate current and future staffing. By deconstructing two existing cubicles, we will expand our main floor meeting area. We also will repurpose one office into a first floor conference room.

One of the tenets of our Cornerstones Strategic Plan is "Organizational Stability" and assuring that ACCF will be here to meet the needs of our community well into the future. That includes making certain the necessary infrastructure is in place...people, systems and physical space.

"As a community foundation, we believe that philanthropy is not just for the wealthy, but for everyone," said Jim Cutright, ACCF President/CEO. "This anniversary program underscores the community foundation's mission to encourage thoughtful giving and effective grantmaking for the benefit of Ashland County."

This opportunity is for donors who do not already have a personal, named fund relationship with us but who have always desired to give back to the community by investing in its future.

"A \$5,000 boost toward creating a new fund opens up possibilities for charitably-minded people who want to make a lasting positive impact in their community, as well as, perhaps, a more attainable entry point for younger donors," Cutright said.

Nonprofit organizations without an Agency Endowment Fund are also able to utilize this offer to begin building sustainability for their organization by creating a source of annual endowment income.

Donors may complete their fund immediately or pledge to make their contributions over a period of five years. No distributions can be made until the minimum threshold is reached and the endowment is fully-funded.

At the first two Women's Fund EmpowHer Circle events, the women raised \$660 for OhioHealth Foundation's project to purchase a special camera for the Sexual Assault Nurse Examiner at the OhioHealth Ashland emergency room as well as \$1,146 for Ashland Special Needs Ministry's respite care program.
